In continuation to tele-conversation yesterday by Shri G.P.Singh our Jt. Secretary General RSCWS. I am pleased to propose for Empanelment of your Hospital with RSCWS (Railway Senior Citizens Welfare Society) Chandigarh to provide medical facilities as per CGHS rates for IPD, OPD & Diagnostics tests for the various available specialties on payment by cash, Credit/Debit Card by the Members of RSCWS.

On having this agreement, Railway employees and member of RSCWS residing in the near vicinity of the Hospital will be able to avail medical facilities on CGHS rates on payment basis. Hospital charges paid as per CGHS rates for any emergency treatment by the Railway employee (retired or in-service), is valid for reimbursement of expenses made on their treatment from Railway.

You are requested to appraise and expedite acceptance of the proposal of treatment on payment as per CGHS rates for RSCWS members having valid ID Card of RSCWS. An agreement (MOU) with details of terms and conditions will also require to be signed for information and record of RSCWS and Railway authorities to accept medical bills of treatment for reimbursement of expenses made for the patient.
