1.0	<p><u>Issues regarding CTSE</u></p> <p>The present procedure for issue of CTSE Card is very complex and user unfriendly. Despite follow up, very few cards have been issued.</p> <p>The main reason is linking user data with ARPAN and matching of the applicant's detail with Aadhar Card. Since ARPAN data itself is not updated as it is mostly being used for pension revision purpose, the applicant's data often does not tally with ARPAN database.</p> <p>Considering the above, it was decided to have a relook of the entire system with a view to simplify it and make it user friendly. Basically the CTSE card is an add-on to the RELHS card which is already available with the retirees. Thus having one online window where the applicant shall submit the required details/upload the documents which will be verified by the concerned officer and process for issue of CTSE card can be examined. 2.0	<p>Sharing of IPAS Data PED/Accounts and MD/CRIS agreed to share the IPAS data with Personnel officers in the field. A table structure of the existing data in IPAS was also provided by GM/Finance/CRIS during the meeting. This shall be studied by Sr.DPO & Sr.DFM/Delhi Division under guidance of ED/ERP/RB to formulate a policy for defining user requirement; level and extent of control over data alongwith the checks required at various levels to ensure sanctity of the data. The above committee shall submit a report within a period of two weeks which will be vetted by CRIS and PED/Accounts/RB for finalising the policy document.</p> <p>It was informed by ED/ERP that earlier a query window was available to Personnel Deptt. Admn to view the required data which has now been disabled. It was agreed by CRIS to restore the above facility.</p>	<p>MD/CRIS PED/Accounts ED/ERP Sr.DPO/DLI Sr.DFM/DLI</p>
3.0	<p>Development of HRMS application</p> <p>(i) MD/CRIS informed that CRIS has forwarded detailed estimate of HRMS to Railway Board for examination and comments. ED/ERP informed that he has examined the detailed estimates and will be sending the comments shortly.</p> <p>(ii) ED/ERP informed that he has already sent the details of 07 modules of HRMS application for phase-I. He will further send the remaining modules by first week of March after its clearance by the Steering Committee in its next meeting scheduled on 15.02.2018.</p> <p>(iii) MD/CRIS informed that the vacancy of GM/HRMS has been notified. We should select and post an officer having relevant experience early. HRMS system will also require experienced retired officer as Project Officer who will assist in development and testing of the HRMS application.</p>	<p>MD/CRIS ED/ERP</p>
