The undersigned here by requests for the following particulars of information

a) Subject: Procedure for Medical Treatment of Railway Beneficiaries / RELHS Optees in Government & Private Empanelled Hospitals

b) Information Description

i) a) Copies of Rules and latest orders or any confidential instructions if any, Reg. Cashless Treatment to Railway Beneficiaries covered under RELHS-1997, if the Patients are admitted in Private Empanelled Hospital in "Emergency" for Railway Beneficiaries covered under RELHS-1997

b) Copy of Orders reg. Powers of AMO (Authorised Medical Officer) i.e. CMS etc. for approving Cashless Treatment in Cases Admitted in Empanelled Private Hospital in "Emergency".

c) Conditions under which such an approval can be denied by the AMO for Cashless Treatment in Cases Admitted in Empanelled Private Hospital in "Emergency".

d) Copy of Orders reg. Delegation of Powers to someone in the absence of AMO (Authorised Medical Officer) i.e. CMS etc. for approving Cases of Admitted in Empanelled Private Hospital in "Emergency"

e) Copy of the Model Agreement with Empanelled Private Hospitals for Cashless Treatment of Railway Beneficiaries / RELHS – 97 Optees.

b) Are the Powers of AMO (Authorised Medical Officer) discretionary or governed by some instructions and guidelines of Railway Board, regarding referring Patients to Government or Empanelled Private Hospitals even though both of them are covered under CGHS Rates?

c) Copies of Rules, Orders & Instructions regarding b) above.

iv) Procedure for getting Advance for treatment in PGI and other Government / Private Hospitals in case of serious Medical Problems etc.

vi) Policy & Orders reg. Transparency & awareness of Rules among Railway Beneficiaries / RELHS Optees regarding Referral and procedure for Treatment in Emergency and Reimbursement etc.


