Subject: Revision of 1/3rd commuted portion of pension as per 7<sup>th</sup> CPC Report - in respect of government servants who had drawn lump-sum payment on absorption in Central PSU/Central Autonomous bodies

Reference: DOP&PW OM No. 4/38/2008- P&PW(D) Dated 15/09/2008

- 1. We, as an Identified Association of Pensioners under the Pensioners Portal for redressal of grievances of Pensioners, draw your kind attention to the non-Revision of 1/3rd commuted portion of pension as per 7<sup>th</sup> CPC Report in respect of government servants who had drawn lump-sum payment (of Commutation of Pension) on absorption in Central PSU/Central Autonomous bodies.
- 2. Orders had been last issued vide DOP&PW OM dated 15-9-2008 cited above for Revision of 1/3rd commuted portion of pension as per 6<sup>th</sup> CPC Report, in respect of government servants who had drawn lump sum payment on absorption in Central PSU/Central Autonomous bodies.

This was done just within a fortnight of the issue of orders for Revision of Pension of other Pre-2006 Central Government Pensioners on 1-9-2008.

- 3. It is regretted that no orders have as yet been issued for Revision of 1/3<sup>rd</sup> Pension of the said PSU Absorbees as per 7<sup>th</sup> CPC, causing much hardship to them despite the fact that more than 9 months have passed since acceptance of the 7<sup>th</sup> CPC Report by the Government and issue of orders thereon for Revision of Pension of other Central Government employees and particularly since no decision has also yet been taken about the Restoration of balance 2/3<sup>rd</sup> Pension after 15 years of Commutation, as per judgment of the Supreme Court in REVIEW PETITION (CIVIL) NO. 465 OF 2017 IN CIVIL APPEAL NO. 6048 OF 2010 Decided on 22-3-2017.
- 4. It is, therefore, requested that orders may please be issued for Revision of at least 1/3rd commuted portion of pension as per 7<sup>th</sup> CPC Report in respect of government servants who had drawn lump-sum payment on absorption in Central PSU/Central Autonomous bodies; and for Stepping up of notional full pension w.e.f. 01.01.2016 for the purpose of Dearness relief and additional pension for old pensioners.
