1. The undersigned hereby requests the supply of the following information under RTI Act, 2005  
Regarding: Issue of Revised PPOs as per Orders on 7<sup>th</sup> CPC

2. Description of Information :

- i) Total Number of Pre-2016 Pensioners of Northern Railway as on 1-1-2016 (*as per Records of FA&CAO NR OR as per Debit Scrolls for December, 2015 received from PDA Banks*).
- ii) Unit-wise (Division & Workshop wise) Number of Pre-2016 Pensioners of Northern Railway as on 1-1-2016 (*as per Records of FA&CAO NR OR as per Debit Scrolls/ Related Docs received from the PDA Banks for the Pension Paid in December, 2015*).
- iii) Number of Revised PPOs of Pre-2016 Pensioners NOT yet Received from the Units by FA&CAO Office (say up to 31<sup>st</sup> May, 2019)
- iv) Number of Revised PPOs of Pre-2016 Pensioners returned to Units by FA&CAO Office (after countersigning) for Record & for being sent further to the Pensioners / Family Pensioners.
- v) Number of Revised PPOs of Pre-2016 Pensioners Pending with FA&CAO Office for being sent to Units for further disbursal to the Pensioners / Family Pensioners.

- viii) Copies of feedbacks received from PDA Banks (CPPC wise) regarding Revision of Pension as per Revised PPOs.
- ix) Copies of Reports sent to Railway Board Regarding Position of Revision of Pension cases by Banks, in terms of Railway Board's letter No. 2016/AC-II/21/8/Pt.VI dated 30-5-2018.
- x) Copy of Orders of concerned authority directing the (Northern) Railway to send the Revised PPOs to Regional CPPCs (e.g. SBI Chandni Chowk New Delhi & PNB CPPC Karol Bagh, New Delhi) instead of local CPPCs (i.e. SBI CPPC Panchkula & PNB CPPC Chandigarh) (*resulting in huge pendency at Regional CPPCs*).
