We seek your kind intervention on a matter of serious concern to the old Pensioners / Family Pensioners of the Railways – settled in this region – some of whom are not being paid additional Pension / Family Pension and / or the DA thereon - as admissible to them in terms of orders of Government of India and Ministry of Railways – issued from time to time.

As per orders cited above 20% Additional Pension / Family Pension is admissible after the age of 80 years; 30% after 85 years, 40% after 90 years, 50% after 95 years and 100% additional Pension / Family Pension is admissible after 100 years of age. Relevant Extract / Copies of these orders are attached, herewith, for ready reference.

Some of the Banks are not paying the above said additional Pension to those concerned and are even asking for a copy of relevant orders from the helpless poor old Pensioners – even when the orders are available on the Websites of the Government of India and of the Railways – on the following links:

Sub: Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission- Revision of pension of pre-2006 pensioners/family pensioners etc.

In pursuance of Government's decision on the recommendations of Sixth Central Pay Commission, the Department of Pension & Pensioners' Welfare (DOP&PW), vide their O.M. No. F.No.38/37/08-P&PW (A) dated 1st September, 2008, has issued instructions for revision of pension of pre-2006 pensioners/family pensioners, which are available on websites (i) india.gov.in and (ii) finmin.nic.in. In terms of para 2.1 of the O.M., the instructions contained therein apply to all pensioners/family pensioners, who were drawing pension/family pension on 1.1.2006 under the Central Civil Services (Pension) Rules, 1972, CCS(Extraordinary Pension) Rules and the corresponding rules applicable to Railway pensioners. The corresponding rules applicable to Railway pensioners/ family pensioners are Railway Services (Pension) Rules, 1993, and Railway Services (Extraordinary Pension) Rules, 1993. A copy of said O.M. may be downloaded and in compliance with the instructions contained in paras 11 & 12 thereof, action to issue revised PPOs, in respect of Railway Pensioners/family pensioners, wherever necessary, taken as expeditiously as possible.

OFFICE MEMORANDUM

Sub: Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission - Revision of pension of pre-2006 pensioners/family pensioners etc.

4.5 The quantum of pension/family pension available to the old pensioners/ family pensioners shall be increased as follows:-

<u>Age of pensioner/family pensioner</u>	<u>Additional quantum of pension</u>
From 80 years to less than 85 years	20% of revised basic pension/ family pension
From 85 years to less than 90 years	30% of revised basic pension / family pension
From 90 years to less than 95 years	40% of revised basic pension / family pension
From 95 years to less than 100 years	50% of revised basic pension / family pension
100 years or more	100% of revised basic pension / family pension

The amount of additional pension will be shown distinctly in the pension payment order. For example, in case where a pensioner is more than 80 years of age and his/her consolidated pension in terms para 4.1 and 4.2 above is Rs.10,000 pm, the pension will be shown as (i).Basic pension=Rs.10,000 and (ii) Additional pension = Rs.2,000 pm. The pension on his/her attaining the age of 85 years will be shown as (i).Basic Pension = Rs.10,000 and (ii) additional pension = Rs.3,000 pm.
