Employees under CGHS scheme.

Through this reminder, you are requested to look at above referred letters & get suitable MOU signed with AIIMS and PGIs in Northern area of your Jurisdiction for Cashless treatment to every railway employee in service or retired at PGIs and AIIMS hospitals in line with the facilities available for Government employees under CGHS scheme.
