1. **Preamble:** I, Jaspal Singh Saggu, r/o Flat No. 1020/1, First Floor, Sector 45-B, Chandigarh-160047, seek the following information under RTI Act 2005 – especially in view of the fact that most of the affected Railway Pensioners have not yet received the arrears even after more than 6 months of issue of above cited orders of DOP&PW & MOR as the Banks have refused to pay the arrears in the absence of any orders from the MOR – unlike the Defence Pensioners who have all received the arrears long back in view of clear cut orders to the CPPCs & PDA Banks to pay the arrears to the concerned Pensioners vide Para 7 of MOD Circular No. 548 Dated 11-9-2015 (copy sent to Rly. Board vide RSCWS letter cited above)

2. **Information sought under RTI Act 2005:**
