I am directed to refer on the above subject and to intimate that the Govt. of Punjab, Department of Finance (Finance Pension Policy & Coordination Branch), Chandigarh vide letter No. 03/02/2024-3FPPC/328 dated 29.08.2024 (copy enclosed) addressed to All Pension Drawing Banks of the State of Punjab has conveyed the decision to stop the recovery of Commuted Value of Pension till the vacation of stay orders from all pensioners(including Petitioners) of the State Government who have completed 10 years of retirement or above.

In pursuance of Government of India, Ministry of Home Affairs, Notification bearing No. 14012/2/88-CHD dated 13.1.1992 read with the Chandigarh Administration, Home Department's letter bearing No. 8846-IH(4)-92/19636 dated 29.10.1992, the Chandigarh Administration is pleased to adopt the aforesaid letter dated 29.08.2024 and decided to stop the recovery of Commuted value of Pension till the vacation of Stay orders, from all pensioners (including petitioners) of Chandigarh Administration who have retired from service on or before 31.03.2022 and have completed 10 years of retirement or above. However this decision will be subject to any subsequent directions/orders passed in various litigations pending/contemplated in the Court of Law.


3. The contents of these instructions may be brought to the notice of all concerned under your control for strict compliance of the above decision.
