### Memorandums Submitted by RSCWS to Various Departments & Ministries

- 1 Memorandum No. 2024-28/RSCWS/CHD/RB-RELHS Dated 13-12-2024 to Chairman & CEO Railway Board and DG, (RHS), Railway Board
- Sub:-i) Permanent Extension of Cashless OPD treatment in Private Empanelled Hospitals for RELHS Beneficiaries as available for CGHS beneficiaries. ii) Extension of the scheme should be done for pensioners aged 70+.
- **Brief:-** Provision of Cashless OPD consultation & related investigations as a Pilot Project for from 1.11.2023 to 31.10.2024 for RELHS beneficiaries aged 75 years & above from specialists of Private Empanelled Hospitals by Railways has been expired without effective run for 12 months. RSCWS submit an Appeal to competent authorities to review trial results and extend scheme for trial of two years instead of extension for one year.
- 2 Memorandum No. 2024-27/RSCWS/CHD/RELHS DRM UMB Dated 23-12-2024 Addressed to DRM UMB
- Sub:- Access of Medical facilities at Chandigarh Tricity area for RELHS beneficiaries.
- Ref:- No. RSCWS/HO/CHD/SPSB/Memo DRM-UMB/2023-18 dated 18-12-2023
- **Brief:-** We are thankful to DRM Northern Railway for the Lock-up dispensary at Mohali Railway Station platform 1 on 3rd October, 2023. The facility is available on every Tuesday and Friday (except Holidays). This dispensary would have been much relief to the number of Railway Beneficiaries settled in and around Mohali if a doctor is also available along with the pharmacist at this Lock-up dispensary, vide above referred letter dated 18.12.2023 We have requested for provision of doctor at Lockup dispensary on the days it is open. Otherwise RELHS beneficiaries are forced to attend Chandigarh Dispensary to see the Doctor and take medicines from Chandigarh itself. RELHS has requested Railway Authorities for improving medical facilities and suggested for:-
  - 1. Expansion of RELHS Hospital network in Tricity and front-line help desk in Government & Pvt. Hospitals
  - 2. Increased Working days of Lockup dispensary at Mohali.
  - 3. Improved doctor to patient ratio as per laid down norms for seamless health delivery system.
  - 4. Upgradation of Lockup Dispensary at Mohali to Railway Health Unit.
  - 5. Improved Infrastructure at RHU-CDG to address the needs of Indoor Patient, especially emergency Treatment and Ambulance

- 3 Memorandum No. No. 2024-26/RSCWS/CHD/PCMD Dated 13-12-2024 addressed to PCMD, Central Hospital, and New Delhi.
- Sub:- Regarding Extension of Pan India Cashless Treatment facilities to Railway Beneficiaries at AIIMs & PGIs (at par with other Central Government employees & Pensioners/ CGHS Beneficiaries).
- **Brief:-** MOH&FW have signed MAO with AIIMS and PGIs vide reference at 4 and 5 above. PGI Chandigarh has appointed a Nodal officer to ensure cashless treatment to CGHS beneficiaries. Railway is also the Central Govt body and you are requested to explore possibilities to have tie-ups and make sustainable system for cashless treatment to Railway Pensioners and in-service Railway employees at AIIMS and PGIs in line with the facilities exists for Central Govt. Employees under CGHS scheme.
- 4 Memorandum No. 2024-23/RSCWS/CHD/Health care Dtd. 20-10-2024 addressed to CPO, N. Rly. & Sr. DPO/UMB
- Sub:- Healthcare Services Standing Committee formed by Railway Board to collect the actual problems faced by the RELHS beneficiaries at Zonal level and Divisional level.

- **Brief:-** Letter from RSCWS has been sent to COP Railway, Sr. DPO/NR/UMB and copy to Railway Board for nomination of representatives from Pensioner's association for Healthcare Services Committee at Zonal level at Baroda House under Chairman ship of CPO and Divisional level Committee under Sr. DPO/NR/UMB. Confirmation is awaited from respective office to attend the meetings convened at both the places.
- Memorandum No. 2024-18/RSCWS/CHD/ Memo DoP & PW Dated 23-07-2024 addressed to Secretary Department of Pension & Pensioner's Welfare
- Sub: Life time Arrears (LTA) Payment of Pension (Nomination) Rules, 1983. (Suggestion for improvement.)
- **Brief:** RSCWS suggested authorities not to close the Pension account after final settlements of pension to the nominee. It needs modification in banking rules. Accordingly guide lines to release pensioners arrears accrued after the demise of the pensioner to the nominees in the original bank account will be modified and separate record of LTA nomination will not be required.

- Sub:- To Safeguard the Interest of Pensioner from Fraudsters.
  - 1. It was earlier requested to Heads of the Central Pension Processing Centres (CPPCs) via e-mail dated 21-06-2024 to alert all the pensioners to be cautious from fraudsters and their forgery activities. In this regard, it is informed that fraudsters are impersonating officials from the Central Pension Accounting Office (CPAO) and contacting pensioners. These scammers are sending forms via WhatsApp, claiming that failure to fill them out will result in stoppage of pension payments for next month. And believing it as a genuine call, our innocent pensioners/family pensioners fall into the trap of fraudsters.
  - 2. Hence, it is again solicited to all the CPPCs to inform all the pensioners to be cautious and not fall victim to these scams and to guide them not to share their personal information, including PPO number, Date of Birth and Bank Account Details with anyone. Moreover, CPAO, Banks and other Government agencies will never request such information from pensioners.
  - 3. It is, therefore, requested to take necessary action at your end for saving valuable pensioners from such fraudsters and their forgery activities.

Attention is invited to the provisions contained in Para No. 11.1.(vi) of 'Scheme for Payment of Pension to Central Government Pensioners by Authorised Banks' (Fifth Edition, July 2021) according to which CPPCs of authorised banks are to credit the monthly pension/family pension in the account of pensioner/family pensioner by the last working day of the

month to which they relate except for the month of March for which it should be credited on the first working day of the succeeding month i.e. April.

Advance Reservation Period (ARP) has been reduced from 120 days to 60 days, vide Board's letter cited under reference (i) above. Consequently, queries are being received from Railways as well as employees regarding validity period of Privilege Passes/Post Retirement Complimentary Passes (PRCP)/Widow Passes.

In this context, attention is invited to instructions contained in Para-2 of Board's letter cited under Ref. (ii) above, issued with the concurrence of Finance Ministry of Railways, wherein it was stipulated that the validity period of PP/PRCP/WP and PTOs shall 1 month more than the ARP but will br not less than 4 months, if ARP is reduced in future.

5. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. No.2021/PG/6/1/DOARPG/Policy on CPGRAMS Dated 19-09-2024 Addressed to AGMs/ZRs All Indian Railways GMs/PUs CMDs/PSUs DG/RDSO

Sub: Comprehensive guidelines for handling the Public Grievances.

Ref: Railway Board's letter of even number dated 01-09.2022.

Kind attention is invited to Railway Board's letter dated 01.09.2024 referred above conveying detailed guidelines / timelines as formulated by the Department of Administrative Reforms & Public Grievances (DARPG) i.e. nodal Department, regarding handling of public grievances and strengthening of redressal mechanism on the Railways through CPGRAMS.

A further review of the aforesaid guidelines has since been undertaken by the DARPG to make CPGRAMS more sensitive. Pursuant thereto DARPG has issued revised guidelines on handling public grievances through CPGRAMS.

In this regard, a few the salient measures, for strengthening CPCRAMS, are as under:

- i. Integrated user-friendly grievance filing platform: DARPG has communicated that an integrated user-friendly grievance filing platform will help citizens to provide single window experience and wider accessibility to various PC platforms of Central Ministries/Departments as well as States/UTs and will also help deduplication and save time and efforts of officials from resolving same grievances on multiple portals.
- ii. Time Limit: Timeline for resolving the grievances has further been reduced to 21 days from existing timeline of 30 days. The grievances of urgent/priority nature identified by the system or where early action is critical. shall be attended to promptly and resolved maximum within 3 days.
- iii. Redressal/Closure of Grievances: DARPG has redesigned its existing Action Taken Reports (ATR) on CPGRAMS to ensure faster closure of frivolous cases. In such cases identified by the Grievance Redressal Officer (GRO) as frivolous, CROs would not require to submit detailed ATR and feedback will also be disabled on such grievances.
- iv. Benchmarking Performances: Grievance Redressal Assessment Index (GRAI): A comprehensive GRAI has been introduced by DARPC to assist the Ministries/Departments to review, analyse and streamline their internal grievance redressal mechanism with SWOT analysis. GRAI is based on 4 dimensions of Efficiency, Feedback, Domain and organizational Commitment. It ranks the Ministries/Departments on their relative performance for effective handling of grievances.
- v. Review of PG cases/PG Appeals in Senior Officers Meetings (SOMs): To ensure quality disposal, the secretary of the Ministry (Apex level in Railway set up) may review disposal process in senior officers' meetings.
- 6. LTA nomination letter reference with complete process as issued by Department of Pension & Pensioners' Welfare Government of India Ministry of Personnel, P.G. & Pensions Ref: No. 1/2(40)/2022-P&PW(E) dated 31 March 2022
- Sub: Nomination by pensioners under the Payment of Arrears of Pension (Nomination) Rules, 1983 for payment of life-time arrears

- 1. In accordance with the Payment of Arrears of Pension (Nomination) Rules, 1983 notified on 10.09.1983 (Annexure-1), pensioners who retired before the notification of the Rules were required to submit nomination to the respective Pension Disbursing Authority. Every employee who retired or will retire after the notification of the Rules, was/is required to submit the nomination, in triplicate, in <a href="Form">Form "A"</a> to the Head of Office or the Department from where he retired/ is retiring. The Head of Office is required to return a duly attested duplicate copy of the nomination in <a href="Form">Form "A"</a> to the pensioner. The triplicate copy of the nomination is to be passed on to the Pension Disbursing Authority along with the Pension Payment Order, through the PAO/CPAO.
- 2. The pensioner can, subsequently, modify the nomination (if nominee pre-deceases the pensioner, or otherwise) by submitting Form "A" in triplicate to the Pension Disbursing Authority. The Pension Disbursing Authority is required to return to the pensioner the duly attested duplicate copy of the nomination within thirty days of the receipt of nomination. The triplicate copy is to be sent to the Accounts Officer of the Department from where the pensioner had retired while the original copy of the nomination shall be recorded with the PDA. If any arrears of pension accrue after the death of a pensioner, such arrears of pension are paid to the person in whose favour a nomination under the Payment of Arrears of Pension (Nomination) Rules, 1983 exists.
- 3. Representations have been received in this Department from some pensioners/pensioners' associations that, quite often, when pensioners submit their nominations to the Pension Disbursing Authority (PDA), there is reluctance on the part of the bank staff to accept these nominations as they are not quite conversant with the above rules. Further, in case a nomination is accepted by the bank, the pensioner is not aware of its safe custody and its retrieval when needed because he is not sure whether the nomination has been fed into the system of the Bank.
- 4. The matter has been examined in this Department. The procedure for submission and acknowledgement of nominations for life-time arrears of pension is well defined in the Payment of Arrears of Pension (Nomination) Rules, 1983. All retiring Government employees are mandatorily required to submit the nomination for arrears of pension in Form A while filling up the pension papers. This nomination is then forwarded to the Pension Disbursing Authority along with the PPO.
- 5. In most cases, the problem of non-availability of nomination may be due to improper handling of the nominations by the Banks, as the Banks may not be keeping a proper record of the nominations. The problem may also arise if the nomination submitted at the time of retirement becomes invalid on account of the nominee predeceasing the pensioner or for some other reason and the pensioner fails to submit a fresh nomination to the Bank in Form A or the staff in the Bank Branches does not accept the nomination due to ignorance.
- In view of the above, all Ministries/Departments, Accounts Offices/CPAO and Pension Disbursing Authorities/Banks are enjoined upon to strictly follow the procedure for handling of the nominations of the pensioners submitted under the Payment of Arrears of Pension (Nomination) Rules, 1983. In short, the following actions are required to be taken by Ministries/Departments, Accounts Offices/CPAO and Pension Disbursing Authorities/Banks in this regard:

#### Actions by Ministries/Departments and attached/subordinate offices thereunder

- i. Obtain nomination in Form A from the retiring employees, in triplicate. The Head of Office or Department must return the duly attested duplicate copy of the nomination to the retiring employee, as acknowledgement, within 30 days of the receipt of nomination from the retiring employee.
- **ii.** Affix the acceptance of nomination in the triplicate copy of the nomination form and forward it to the Accounts Officer, along with the pension papers/pension case, for onward transmission to the CPAO/Pension Disbursing Authority along with the Pension Payment Order.

#### **Action by the Accounts Officers**

Forward the triplicate copy of the nomination form, duly accepted by the Head of Office, along with the Pension Payment Order, to the Central Pension Accounting Office for onward transmission to the Pension Disbursing Authority along with the Pension Payment Order/Special Seal Authority.

#### **Action by the Central Pension Accounting Office**

Forward the triplicate copy of the nomination form, duly accepted by the Head of Office, along with the Pension Payment Order to the Pension Disbursing Authority/Bank along with the Pension Payment Order/Special Seal Authority.

#### Actions by the Pension Disbursing Authority/Bank

- i. Retain the triplicate copy of the nomination of the pensioner, as received from Accounts Officer/CPAO, for record.
- **ii.** Keep a proper record in their system in respect of the nominations received from the Accounts offices/CPAO.
- iii. Review the availability of nomination under the Payment of Arrears of Pension (Nomination) Rules, 1983 in respect of all pensioners. In case, nomination in respect of any pensioner is not available in the record of the PDA/Bank, the concerned pensioner may be advised by the PDA/Bank to submit the same in Form A forthwith
- iv. Accept any modification of existing nomination/fresh nomination from the pensioner in Form A (in triplicate) of the Payment of Arrears of Pension (Nomination) Rules, 1983 and return to the pensioner the duly attested duplicate copy of the nomination within thirty days of the receipt of nomination.
- v. Send the triplicate copy of the nomination to the CPAO/Accounts Officer of the Department from where the pensioner had retired and retain the original copy of the nomination for record.
- vi. Instruct the staff dealing with pensioners to accept any fresh nomination or modification in the existing nomination submitted by the pensioners in Form A.
- vii. Keep a proper record in their system in respect of the fresh nominations/modifications received from the pensioners.
- viii. Indicate the status of availability of nomination under the Payment of Arrears of Pension (Nomination) Rules, 1983 in Pension Seva Portals or any other similar portal maintained by them.
- ix. Indicate the status of availability of nomination under the Payment of Arrears of Pension (Nomination) Rules, 1983 in the monthly pension slips issued by them to the pensioners.
