**Sub: - Access of Medical facilities at Chandigarh Tricity area for RELHS beneficiaries.**

**2. No. 2024-27/RSCWS/CHD/ RELHS DRM UMB Dated 13.12.2024**

**Brief: - Deployment of Railway Doctor at lock-up dispensary at Mohali Railway Station to avoid going to Railway Health Unit at Chandigarh. Expansion of Hospital network in the tricity for the RELHS beneficiaries and upgradation of RHU/CDG to a Divisional/Sub-divisional Hospital. To simplify by the referral system by delegating the power of referral to DMO/RHU/CDG instead of sending the Railway Beneficiary to Div. Hospital/UMB or CH/NDLS.**

- 2 Memorandum No. 2025-03/RSCWS/CHD/ Memo DoP&PW Dated: 16.03.2025 Addressed to Sh. Jitendra Singh Minister of State for Personnel, Public Grievances and Pensions of India Anusandhan Bhawan, 2 Rafi Ahmed Kidwai Marg, New Delhi – 110001**

**Sub: - Concerns of Pensioner to be taken care of by 8th Central Pay Commission**

**Brief: - Highlighted the concerns of pensioners while accepting the recommendations of the 8<sup>th</sup> CPC which includes, Rationalisation of Multiplier Factor on the basis of real-time data. Timely Issuance of Revised PPOs. Provision of Interim relief in case of delayed submission of recommendations of 8<sup>th</sup> CPC conforming to the hike in the minimum pension.**

- 1. Government of India, Ministry of Railways, (Railway Board) No. PC-VI/202/CC/13 New Delhi Dated: - 19-02-2025 issued by Executive Director, Pay Commission Railway Board.**

**Sub: - Grant of notional increment (as due on 1<sup>st</sup> July/1<sup>st</sup> January) for the pensionary benefit to those employees who had retired on 30<sup>th</sup> of June/31<sup>st</sup> of December before drawing the same.**

**Brief: - Honorable Apex Court order dated 06-09-2024 clarified after consulting legal directorate & Finance Directorate that “those pensioners who are eligible otherwise for grant of notional increment but have not joined as a party to any of the court cases or resorted to any litigation process on the issue of notional increment.”**

- 2. Government of India, (BHARAT SARKAR) Ministry of Railways (RAIL MANTRALAYA), (Railway Board) No. F(E)III/2024/Misc.3R New Delhi Dated 26-03-2025. Issued by Director, Finance, Railway Board.**

**Sub: Restoration of Commuted portion before 15 years from the date of commutation.**

**Brief – The issue examined in consultation with nodal Department on pensionary matters (DoP&PW) is clarified as under: - “The law regarding commutation has been well settled by the Hon’ble Supreme Court vide their judgement dated 09-12-1986 in writ petition No. 3958-61 of 1983 “Common Cause” Society & others (Petitioners) Vs Union of India (1987 (1) SSC 142) in 1986. The Supreme Court considered all relevant factors like interest rate, mortality rate etc. and the commutation table in existence in 1986 and gave a decision that the commutation period should be fixed as 15 years.”**

- 3. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. No. 2023/H/28/1/RELHS/Empanelled(CGHS) New Delhi Dated 02-01-2025 issued by Executive Director Health(G)**

**Sub: Provision of OPD Consultation and related investigation for RELHS Beneficiaries from specialist of Private Hospitals empanelled by Railway As a pilot project for next 03 years from 01-11-2024 to 31-10-2027**

**Brief: - The pilot project has been examined in Board’s office in consultation with Finance Directorate and with the approval of competent authority, it has been decided that the pilot project is extended to RELHS beneficiaries aged 70 years and above for next 03 years from 01-11-2024 to 31-10-2027.**

- 4. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. 2021/H-1/11/10/MoU New Delhi Dated 10-02-2025 issued by Director Health, Rly. Bd.**

**Sub: - Changes in Para 7 of the Draft MoUs to be entered between HCOs and Railways.**

**Brief:** - In order to extend facilities of OPD consultation & related investigations for RELHS beneficiaries aged 75 years and above from specialists of private empanelled hospitals by Railways on cashless basis as pilot project for one year from 01-11-2023 to 31-10-2024, a para 7(iv) has been inserted in the Draft MoU vide Board's letter of even No. Dated 20-11-2023.

Now the pilot project to provide OPD consultation & investigation facilities has been extended to RELHS beneficiaries aged 70 years and above for next 03 years i.e. from 01-11-2024 to 31-10-2027 vide board's letter No. 2023/H/28/1/RELHS/Empanelled (CGHS) Dated 02-01-2025.

Accordingly, following changes in para 7 of the Draft MoU issued vide Railway Board's letter dated 20-11-2023 have been made:

**Para 7(iv):** RELHS beneficiaries aged 70 years and above (having valid UMID card and not getting FMA) seeking direct OPD consultation (not including issue of medicines) from specialist of Private Hospital empanelled by Railway, without referral from Railway Hospital/Health Unit under which beneficiary is registered.

**Para 7(iv)(a):** This facility will be available for only those aged 70 years and above RELHS beneficiaries (having valid UMID card) who are eligible for OPD consultation at Railway Hospitals/Health Unit. This facility is not available to beneficiaries having UMID card with FMA.

**Para 7(iv) (f):** The pilot project is extended for 03 years i.e. from 01-11-2024 to 31-10-2027 beyond 31-10-2024.

**5. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. 2015/H/6-4/Policy New Delhi Dated 01-01-2025 issued by Executive Director, Health (G) Rly. Bd.**

**Sub:** - Reimbursement claim settlement to Railway Beneficiaries for treatment of cancer in emergency.

**Brief:** - The matter has been examined in consultation with Finance Directorate of Railway Board and it has been decided that on first occasion shall mean "First cycle of Chemotherapy or first cycle of Radiography or surgery, if prescribed by the treating doctor and undergone initially after diagnosis of cancer may be treated as the 'first occasion of treatment' and any subsequent surgery do not fall under the 'first occasion of treatment' and will require permission from authorities concerned"

**6. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. 2015/H/28/Claims Disposals New Delhi Dated 08-01-2025 issued by Executive Director, Health (G), Rly. Bd.**

**Sub:** - Prompt Disposal of Medical Reimbursement Claims.

**Brief:** - The matter of prompt disposal of Medical Reimbursement was examined and decided as under: -

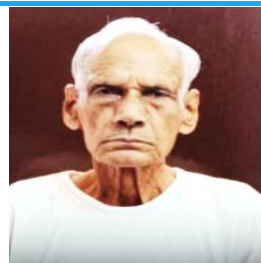
- (a) Reimbursement Claim cases, whose settlement jurisdiction is up to Divisional Level/ Production Unit Level, may be settled within 60 days from its date of receipt in concerned office.
- (b) Reimbursement Claims Cases, whose settlement jurisdiction is Zonal Level may be settled within 90 days from the receipt in concerned office.

**7. GOVERNMENT OF INDIA (BHARAT SARKAR) MINISTRY OF RAILWAYS (RAIL MANTRALAYA) (RAILWAY BOARD) Letter No. 2024/F(E)III-PN/18 New Delhi Dated 30-01-2025 issued by Director, Finance (Estt.) Rly. Bd.**

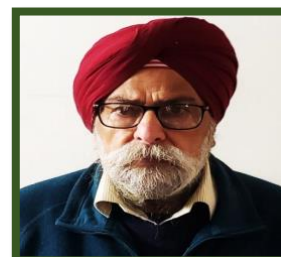
**Brief:** - As per Rule 75(5) of Railway Service (Pension) Rules, 1993 and instructions issued thereunder, as soon as a Railway servant enters railway service, he shall furnish details of his family in Form 6 to the Head Office and if the railway servant has no family, he shall furnish the details in Form 6 as soon as he acquires a family. This rule further provides that the railway servant shall communicate forthwith the Head of Office any subsequent change in the size of his family including the fact of marriage of his or her child. The railway servant is also required to submit updated family details in 'Form 6' at the time of retirement.

2. In this regard it is stated that the railway servant/pensioner shall submit details of all members of family whether or not eligible for family pension. The daughter is deemed to be a member of the family of railway servant as and when intimated by the railway servant in prescribed proforma. Hence, the name of the daughter shall remain included in the details of family members. The eligibility for family pension would be decided after demise of pensioner/family pensioner in accordance with the existing rules.
